

Alternatives to Lexis & Westlaw



Fastcase

Comprehensive

Federal and state case law, statutes, regulations, court rules, constitutions, law review articles

Algorithmic Control

Unique sorting algorithms provide alternative results to LX/WL. Plus, you can re-sort and re-prioritize to fit your research

Data Visualization

Map search results visually to show results over time, relevance, or citation ranking.



Google Scholar

Coverage

Federal and state cases; Article search (not just legal articles)

Flexible Search

By keyword, party name, case citation

Expand

Click on "How Cited" to find citing documents and related documents



Casetext

Coverage

Federal and state case law, statutes, federal regulations, briefs database

Contextual Searching

Upload a complaint, memo, brief, etc., then add keywords to filter, focus your results

Narrow Results

By motion type, cause of action & party type



Oregon Legislative History

Don't reinvent the wheel.

Consult:

- 1) Law Review Articles
- 2) Legislative Tracings

Legislative History, Step-by-Step

- Begin with the ORS citation (look for the history line)
- Session Law -> Bill Number
- Bill Number -> Measure History
- 4) Meeting Minutes/Exhibits

Dates to remember:

<u>Pre-1995:</u> Check for tracing or secondary source, otherwise must use microfilm. Audio only available at Archives.

<u>1995-Present:</u> Check for tracing or secondary source, consult online material from Oregon State Archives. Some material only available at Archives in person (or pay for their research services); after 2007, much of the information needed is available through Legislature's site.

Expeditious & Precise Legal Research

Stepwise Approach:

- 1. KNOW YOUR CASE
 - a. Start where you are and Read It All.
 - b. Plan your project
- 2. List & Look up Cited Materials
- 3. Build a Source/Search List
- 4. Skim & Save -> Read Later
- 5. Verify (Shepardize/KeyCite)
- 6. READ

- Caselaw
- Search Terms
- Resources
